### **About QSO**

The Quality Safety and Outcomes Policy Research Unit (QSO PRU) is a collaboration between the Universities of Kent and Oxford, the London School of Hygiene and Tropical Medicine (LSHTM), the Picker Institute and Hull-York Medical School. It is funded by the NIHR from 1 January 2019 for five years. The purpose of QSO PRU is to produce robust, relevant and usable research to improve the quality and outcomes of the health and social care system. The underlying premise of our work is that improvements in the way we use health and care resources (inputs) will lead to improved outcomes for people using those services, and for staff engaged in providing health and care. Quality is a measure of how well our use of resources translates into outcomes. 

### **Role of Research Advisors**



We aim to involve patients/service users, carers and the public in our research at all stages of the research cycle (see below graphic). We see the role of a Research Advisor as working with individual projects to support the work of the research team and to facilitate academics and other researchers understanding and learning from the 'lived experience perspective'. A Research Advisor can be involved in a variety of activities dependent on the scope

of the project, the needs of the researchers and the research advisor's personal interests. Examples include: reviewing project materials, like a Plain English Summary and ensuring these are understandable to a wide audience, accessible and 'jargon free'; sharing your knowledge, experiences, and insight you have gained through being a carer and/or patient/service user.

Where possible, your role will be negotiated between you and the research team. It may depend upon how much time you have to commit, or the nature of the research.

# Support in your role

We have a system where new Research Advisors can buddy up with an experienced member who will support them in carrying out their work. There are quarterly advice sessions for Researchers and Research Advisors to bring along any involvement and engagement conundrums. We also offer an annual event which Research Advisors can attend to review the work of the QSO PRU and discuss successes and areas for improvement within the PPI process.

# **Payment Policy**

Before you start your involvement work, Lisa will set a time to discuss the policy with you. Payment for your involvement follows the Centre of Engagement and Dissemination payment principles.
